

- 2. Policy-making, by imposing minimum requirements to military aviation: Military Aviation Requirements (MARs);
- 3. Supervision and enforcement of requirements, rules and regulations;
- 4. Assuring total aviation safety approach.





Operations: pilots (fixed wing aircraft / helicopter / UAV / flight testing / training)


Aeronautics & Certification: engineers (aeronautics / avionics / flight testing / cabin safety / maintenance / training)

Aero medics: flight physician

Infrastructure: air traffic controllers / fighter controllers / fire fighting / bird control

Aerospace quality: quality engineers with aviation background


Legal: aviation lawyers (air law)
